Reflections From Our President & CEO As I reflect over our past 40 years, I think about those who looked beyond their own sphere and saw a need for a central place where community members could come and feel welcomed, giving them a sense of connectedness within their community. Father Gaitan, the Archdiocese of Kansas City in Kansas, Richard Ruiz, and the Cordi Marion Sisters saw such a need in the Armourdale and Argentine community somewhere place where community members could gather together, talk, share food and fun, and find out about resources to make their lives fuller and richer. All those years ago with a \$10,000 grant from the Archdiocese, El Centro Servicios para Hispanos was born. Residents flocked to the organization, finding people who had shared experiences, shared language, shared culture, and shared community. The original program, the Senior Day Program, was soon joined by a children's daycare, afterschool tutoring, English lessons, computer keyboard classes, housing, and connections to many other programs and resources.

El Centro has not stood still over the past 40 years, but has grown and changed to meet needs. We strive to be responsive to the community and get clients connected with the services they need. Over the years, we have watched families grow and our children become adults. Children who were in our original daycare program now have children of their own. Some of these children have attended our Academy for Children, a dual-language pre-K school preparing children for educational success, different than our first daycare program. Those graduating our Keyboards to Success and our afterschool tutoring programs have gone on to continued learning and have successful careers. Today we continue to strengthen families by offering them educational, economic, and social opportunities to do so.





El Centro's Community Impact

Our Academy for Children educated more than 100 children in our preschool and summer programs, providing activities and exploration with an educational focus, and working with over 75 pre-K children during the school day on skills in literacy, numeracy, social skills, language, and exploratory play. Parent involvement grew significantly through activities such as Family Nights, parent-teacher conferences, volunteering, and being the proud attendees at our children's performances. Of the 37 students we graduated, 98% were Kindergarten-ready!

Our Health Navigation Program, which serves both Wyandotte and Johnson counties, served 837 unduplicated clients. Through partnerships forged over the years clients were able to resolve billing issues, arrange surgeries, access specialty care, enroll in health insurance (some for the very first time), and receive the service impacting the most lives – the gift of better vision for 356 people through eye exams and eyeglasses. Many others received additional direct assistance including hearing aids, dental care, prescriptions and medical equipment totaling \$109,173.

Our Promotores de Salud Program serves the metro area with community outreach and education, including grocery store and farmers' market tours, cooking classes for healthier eating, and budgeting family food dollars to serve healthier meals to their families for less money than they were spending before. As they are members of the community we serve, they have the language, leadership, and cultural skills to expand participants' knowledge of the Supplemental Nutrition Assistance Program (SNAP). Over the last year, the Promotores signed up 2,123 eligible Latinos- increasing families' knowledge and capacity to live a healthier lifestyle, building better, stronger communities along the way.

Our Economic Empowerment Program

provided emergency financial assistance to 251 clients, representing a total of \$34,259 in services provided. Most of these clients were given individual financial counseling, classroom style courses or were required to take a selfpaced online financial education course to build knowledge. El Centro's Financial Education Courses include topics like money basics, budgeting, managing debt, building credit and saving.
